1. Enrollment and Registration:
  - a. Parents or legal guardians must complete the registration process for their child to secure a spot in the Summer Art Fiesta (send an email to: [info@lauranotari.com](mailto:info@lauranotari.com)).
  - b. All required forms and documents, such as medical information and emergency contacts, must be accurately and completely filled out, and send to: [info@lauranotari.com](mailto:info@lauranotari.com)

  - d. Laura Notari Artist reserves the right to withdraw any service without consulting the participant prior to withdrawing such service and shall have no liability whatsoever to the participant in connection with deletion or elimination of any such service.
2. Kids Summer Art Fiesta Schedule:
  - a. The Summer Art Fiesta will be conducted from 22 July 2024 to 24 July 2024 on weekdays from 9:30 to 16:00.
  - b. The pick-up and drop-off time is at Laura Notari's studio (Noordse Bosje 1, Hilversum), and parents or authorized individuals must adhere to these timings.
  - c. The Summer Art Fiesta schedule may include breaks, lunchtime, and various art activities. A detailed daily program will be provided to parents/guardians before the start of the Summer Art Fiesta.
  - d. The registered participant should come every day wearing comfortable and old clothes, and able to get dirty.
3. Code of Conduct:
  - a. All registered participants are expected to behave in a respectful and appropriate manner towards Summer Art Fiesta staff, fellow participants, and the Laura Notari studio/gallery premises.
  - b. Any form of bullying, harassment, or disruptive behavior will not be tolerated and may result in immediate dismissal from Laura Notari studio/gallery without a refund.
  - c. All registered participants must follow instructions provided by Laura Notari studio/gallery staff for their safety and the smooth operation of the Summer Art Fiesta.

- d. Laura Notari studio/gallery reserves the right to dismiss a registered participant if their behavior is consistently disruptive or endangers themselves or others.
4. Health and Safety:
    - a. Parents/guardians must inform Laura Notari of any known medical conditions, allergies, or other health concerns affecting their child.
    - b. Laura Notari studio/gallery will take reasonable precautions to ensure the safety and well-being of the little artists, including appropriate supervision during activities.
    - c. In case of a medical emergency, Laura Notari studio/gallery will make reasonable efforts to contact parents/guardians and provide necessary medical attention.
    - d. Laura Notari studio/gallery is not responsible for any loss, damage, or theft of personal belongings brought by the registered participants.
  5. Photography and Promotion:
    - a. Laura Notari studio/gallery may take photographs or videos during the Summer Art Fiesta activities for promotional purposes.
    - b. By enrolling their child in the Summer Art Fiesta, parents/guardians grant permission for their child's likeness to be used in promotional materials, including but not limited to websites, brochures, and social media platforms.

    - b. Laura Notari studio/gallery reserves the right to cancel the Summer Art Fiesta due to insufficient enrollment, unforeseen circumstances, or any other reason. In such cases, a full refund will be provided.

    - a. Laura Notari studio/gallery and its staff will not be held liable for any injuries, accidents, or damages that occur during the Summer Art Fiesta, except in cases of gross negligence or intentional misconduct.
    - b. Parents/guardians are responsible for any costs or damages caused by their child to Laura Notari studio/gallery facilities or property.
